MOICT Launches “Food Truck Activity Licensing” Service

As it seeks to support and encourage small individual enterprises, to give them the legal status to perform their activities and to simplify the relevant procedures, MOICT has launched a new service on its Sijilat portal system within the basket of the new distinctive services adopted by MOICT to create an evolving investment environment that facilitates all the services and procedures required to invest in the Kingdom of Bahrain in accordance with the relevant international standards.

What is the “Food Truck Activity” service?

The new service, called “Food Truck Activity Licensing” service, allows the investor, after securely logging into the e-portal “Sijilat” through the eKey account, to apply for the license of this new activity. The activity includes the preparation and delivery of meals from motor vehicles (trucks or trailers).

What are the most important features of “Food Truck Activity” service?

1. Allowing commercial activities to be carried out without having a place of business.
2. Flexibility in doing business
3. Giving legal status to entrepreneurs
4. Possibility of concluding contracts with companies that require a commercial register

Licensing requirements

1. The applicant shall be a Bahraini national.
2. The applicant shall obtain the MOH approval for the interior design requirements of the truck or trailer.
3. The applicant shall reserve sales sites through the Municipality.
4. The applicant shall register vehicles at the General Directorate of Traffic Services after obtaining a commercial register with the necessary licenses before starting the activity.
5. The applicant shall conduct business through the form of sole proprietorship or individuals.
6. A permanent mailing address

Note: Holders of the virtual commercial registers shall not be entitled to permits to bring in foreign workers.

Procedures for obtaining the food truck activity license

First: Through Sijilat system

1. Submit an online application for a food truck activity to register a CR without license through Sijilat system.
2. Obtain the MOH and General Directorate of Civil defence approval for the interior design requirements of the truck or trailer through an obtain license application on sijilat portal.

Second: Offline

1. Reserve sales sites through the Municipality.
2. Register the truck / trailer at the General Directorate of Traffic Services
