

Virtual Commercial Registration

"Sijili"

As it seeks to support and encourage small individual enterprises, to give them the legal status to perform their activities and to simplify the procedures for the establishment of some businesses (entrepreneurs such as photographers, translators, trainers, consultants, etc.) and based on its desire to introduce a new model for the practice of some commercial activities, MOIC initiated a decision to allow some commercial activities - 39 activities - to be carried out without the need to register the entity at the address of an office or place of business.

What is "Sijili"?

Sijili is a commercial registration that grants an individual the ability to practice certain business activities without having to register an office address.

What are the most important features of "Sijili"?

- 1. Allowing commercial activities to be carried out without having a place of business.
- 2. Flexibility in doing business
- 3. Granting legal status to entrepreneurs
- 4. Possibility of concluding contracts with companies that require a commercial register

Licensing requirements

- 1- The applicant shall be a Bahraini national.
- 2- The applicant shall neither be the owner of a sole proprietorship or single-person company nor a director or member of any business (the person who is a shareholder of a company is allowed, provided that he is not a manager or director thereof).
- 3- The applicant shall conduct business through the form of sole proprietorship only.
- 4- A permanent mailing address shall be provided.

Notes:

- 1. Holders of virtual commercial registers in Sijili, shall not be entitled to permits to bring in foreign workers.
- 2. Approvals for licenses shall be obtained from the licensing entities (depending on the requirements of each commercial activity).
